# Marina Regulations

The Palliser Regional Park Authority has the responsibility and the authority to ensure that all Marina regulations are enforced to preserve and protect common areas. Upon receiving notification, violators will be given 24 hours to comply or face subsequent fines and/or removal of their vessel from the property at their expense.

1. Young children must always be under the supervision and responsibility of an adult.
2. ALL dogs must be on a leash and owners must pick up after their dogs. Failure to do so will be cause to expel the dog from the Marina permanently. Please pick up dog waste.
3. Barbecuing is permitted on board a vessel providing that the barbecue is securely attached to the boat (no hibachis or barbecues permitted on the docks.)
4. **ABSOLUTELY NO WAKE WITHIN THE MARINA. IDLE ONLY WITHIN THE MARINA.**
5. The alteration of or attachment of any device to any dock is prohibited. Nothing is to be left on docks or dock railings. All vessels (boats, canoes, kayaks, etc.) must be properly moored in the water.
6. Nothing is to be dumped overboard while docked. All garbage is to be put in the garbage barrels provided throughout the Marina area.
7. All seasonal slip renters must have liability insurance coverage on their boat.
8. NO unlicensed vehicles including ATVs and golf carts (golf carts only on the designated golf cart paths) are permitted anywhere in the park.
9. Due to ongoing upgrades there is NO Guarantee that you will receive the same slip each year. Every year, all seasonal slip holders must have completed and paid for a permit before using the Marina.
10. The permit holder, his/her guests, and their families shall at all times comply with all permit conditions and this park's regulations and bylaws.
11. The boat that you register when you pay for the slip fees is the only boat allowed in that slip, absolutely no sharing of slips.
12. Please remove all boat bumpers at the end of the season. **All boats must be out of the Marina by September 30, 2016.**
13. Storage fees will apply for anyone leaving boats over the winter.
14. **ABSOLUTELY NO FISHING OFF THE DOCKS.**
